# **RESULT NOTIFICATION**

The provisional results of the End Semester Examinations, November 2018, are hereby declared.

#### **Issue of mark sheets**

- 1. Mark sheets for the various programmes and semesters will be issued as below:
  - a) 05 March 2019 BSc 1st, 3rd and 5th Semesters (Old Course)
  - b) 06 March 2019 MSc 1st and 3rd Semesters, including MSc Repeaters
  - c) 07 March 2019 BA/BSc 1st Semester (Repeaters)
  - d) 08 March 2019 BA/BSc 1st Semester
  - e) 11 March 2019 BA/BSc 3rd Semester (Repeaters)
  - f) 12 March 2019 BA/BSc 3rd Semester
  - g) 13 March 2019 BA/BSc 5th Semester
- 2. Students who could not collect their mark sheets on the scheduled dates may do so from <u>14 March</u> <u>2019</u> onwards.

#### **Correction of mark sheet**

While all possible care has been taken to ensure accuracy in the results published, errors, if any, will be rectified as per the examination rules and regulations of the college. Any mistake in the mark sheet must be reported to the college exam branch <u>before 15 April 2019</u>, after which due fees will be charged for any necessary correction.

#### Revaluation

- 1. Revaluation of answer books in any number of papers is permitted.
- 2. The fee for revaluation is ₹500/- per answer book.
- 3. The filled-in application form and prescribed fee should be submitted along with original copies of the mark sheet to the college exam branch <u>before 28 March 2019</u>.

### **BSc (Old Course) Repeaters**

- 1. BSc students registered in 2012 have exhausted the maximum period prescribed for completion of the programme. No more chances of appearing in examinations will be given to them.
- 2. BSc students registered in 2013 who have not completed the programme can apply to clear even semester arrears in End Semester Examinations, May 2019, and odd semester arrears in End Semester Examinations, November 2019, after which the maximum period will be exhausted.

# BA/BSc (CBCS) and MSc students with arrears

1. Students are reminded of the college examination rules & regulations relating to clearing of papers and repeating arrears:

# 4.2 Criteria for Clearing

- 4.2.1 A student is declared to have cleared a semester if he/she clears all papers in the semester.
- 4.2.2 A student is declared to have passed the programme if he/she clears all semesters in the programme.
- 4.2.3 UG programme: A student must clear all papers within 5 (five) years of being enrolled to be declared passed.
  PG programme: A student must clear all papers within 4 (four) years of being enrolled to be declared passed.
- 4.2.4 A student can appear in a paper for a maximum 3 (three) examinations. A student who fails to clear a paper in 3 (three) appearances automatically fails the programme.

#### **3.1** Repeater for arrear paper

- 3.1.1 A student desirous of appearing the examination of an arrear (back) paper can apply accordingly.
- 3.1.2 Only two chances for appearing examinations of an arrear paper are permissible and must be within 2 (two) years of the student's first ESE appearance in that paper.
- 2. Students who have papers not cleared after 2 (two) appearances have **only one more appearance possible** which will have to be in November 2019.
- 3. BA/BSc students who have papers not cleared after 3 (three) appearances have exhausted the maximum period/ number of chances to appear for examination in the respective paper. They will be granted **one more chance in November 2019** on the condition that they sign an undertaking to clear the papers failing which they will automatically be disenrolled from the BA/BSc programme. (List in *Annexure A*.)

Such a student willing to sign the undertaking is to meet the Vice Principal with a parent <u>before</u> <u>28 March 2019</u>.

Any such student who do not sign the undertaking <u>by 28 March 2019</u> will be immediately disenrolled from the BA/BSc programme.
